Possess working knowledge of, & ability to apply the following laws and regulations related to the business activity: United States, Mexican & Canadian Customs, Export Administration Regulations (EAR), International Traffic In Arms Regulations (ITAR), USML, CCL, Anti-boycott, Foreign Trade Statistics (FTSR), Office of Foreign Assets Control (OFAC) General Agreement on Tariffs and Trade (GATT) World Trade Organization Agreements (WTO), & Trade laws of foreign countries.

Analyze, & determine the impact on the business of global laws, legislation, court decisions, and federal regulations. Create and implement standards for export license and license exemption management under the EAR and ITAR: Prepare & submit export license applications for hardware, technical data and services under the EAR & ITAR, including, but not limited to DSP5's and DSP73's.

Develop and submit Technical Assistance Agreements (TAA) and Manufacturing License Agreements (MLA) involving defense articles.

Ensure licenses compliance with the ITAR and CBP. If required, provide training to North American Customs authorities on Schneider Electric and / or Customs Sensors & Technologies intellectual property & trademarks to reduce the potential for unauthorized distribution & counterfeiting.

Provide advice to CST companies' sales & purchasing personnel on international contracts. Oversee and/or support compliance activity of trade compliance personnel located at CST and other CST facilities, ensuring that adequate resources are available & provide feedback on performance.

Where required re-engineer processes, create/modify export policies and procedures. Implement, train on, and maintain export policies and procedures for compliance.

Establish and maintain export recording standards for CST companies to meet the Record keeping requirements of Department of State and Department of Commerce.

Monitor and maintain compliance with the regulations stated above, as well as, plan and strategize to maximize the benefit of international trade between the Schneider Electric companies.

Work with the CST VP Trade Compliance to implement and maintain a 'best-in-class' trade compliance program for all CST companies.
